At this year's forum we will have a terrific space for our vendors and exhibitors—right near the morning coffee service, the plenary ballroom, and several of the breakout rooms. Here you will find an online application to reserve your table. Please be aware that there is a charge of \$120 for each vendor/exhibitor spot. This allows us to cover the charges associated with offering each vendor/exhibitor one table, two chairs, access to wi-fi and electricity.

At our first TLEF in 2010 we had 212 tribal professionals, staff from various federal agencies, and personnel from many private companies. This increased to nearly 350 individuals just three years later. With the inclusion of tribal water programs at this year's forum we are anticipating upwards of 550 attendees - so this is a great opportunity for you to highlight your organization's work!

Lodging and Transportation Information for the 2015 TLEF

Minneapolis is a major airline hub, which should simplify travel issues for our attendees. The city also has a very efficient lightrail system that will take you directly from the airport to the downtown area.

ITEP is currently finalizing negotiations with the hotel where the forum will take place. We anticipate that you will be able to make your hotel reservations, at a special forum rate, by early March. As soon as the special hotel reservation website is up and running we'll let you know.

■ Tribal Waste and Response Assistance Program (TWRAP)

TWRAP is a program focused on assisting tribes with all waste management, brownfields, USTs, contaminated sites, and response programs. This program is funded by the USEPA's Office of Solid Waste and Emergency Response.

■ Tribal Solid Waste Education and Assistance Program (TSWEAP)

TSWEAP's focus is providing training and assistance to tribes working on solid and hazardous waste management.

National Tribal Toxics Council (NTTC)

The NTTC is a USEPA Tribal Partnership Group that is focused on providing Tribes with an opportunity for greater input on issues related to toxic chemicals and pollution prevention.

Navajo Nation Environmental Workforce Development Program (NNEWDP)

The NNEWDP provides training to members of the Navajo Nation so they may secure employment in the fields of environmental cleanup and remediation.
