The 2016 Tribal Lands and Environment Forum has come and gone, and we want to thank all of you who attended this year's forum. We had 490 attendees this year, representing 124 Tribes, six tribal organizations, 13 government agencies, 20 companies, and nine universities and nonprofits. The attendees were offered five field trips, 15 trainings, two plenaries, 49 breakout sessions featuring 79 different presentations, and our first ever Multi Media Meetup activity.

A big thank you to the nearly 100 people who shared their knowledge and passion as presenters at this year's TLEF. You really are the reason this event is such a success and we appreciate your dedication and willingness to share. #### Upcoming ITEP Training Opportunities

ITEP was recently awarded another year of funding from the USDA to continue our trainings on solid waste, as well as offering onsite mentoring activities. We have a brand new training coming up in just a few weeks. We've been working with a terrific group of tribal professionals from various tribes in Minnesota on a **Waste Diversion Strategies and Tribal Food Sovereignty** course, which will take place in Minneapolis September 27-29, 2016. This training will focus on tribal case studies, highlighting successful strategies for implementing and managing various waste diversion activities (such as recycling, composting, and others) and also explore the connections and opportunities for collaboration between waste management programs and growing and protecting traditional foods. We will be offering two additional training courses in early 2017 that will also focus on waste diversion and source reduction strategies. Once those trainings are finalized we will be sending out applications and additional information on them.

## USEPA Encourages Tribes to be Notified When Spills Occur

The National Response Center functions as the sole point of contact for reporting oil, chemical, radiological, biological, and etiological discharges into the environment anywhere in the United States and its territories. The NRC also takes maritime reports of suspicious activity, security breaches, and terrorist related activities for the U.S. Coast Guard and railroad incident reports for the U.S. Federal Railroad Administration.

The EPA is assisting with an outreach effort to encourage tribes to submit applications to the NRC to receive notifications when oil and hazardous materials incidents happen in Indian Country. Tribes are encouraged to apply to receive notifications directly from the federal NRC.
