Two New Special Opportunities at the 2017 TLEF

We are excited to announce that a **new training** and a **new field trip** have been added to Tuesday morning of this year's TLEF in Tulsa.

Professor James Grijalva, Director Northern Plains Indian Law Center's Tribal Environmental Law Project, University of North Dakota School of Law, will be joining us again this year. He will be giving a four hour training on Tuesday morning titled **Strengthening Tribal Self-Determination and Self-Governance by Administering Environmental Protection Programs: The Continuing Relevance of EPA's 1984 Indian Policy & 1992 GAP Statute.**

Our new field trip will also be taking place Tuesday morning. You will have the opportunity to tour the **Lower Bird Creek Wastewater plant** in northeast Tulsa. This special field trip is being conducted as part of the Water & Wastewater Utility Operations training that begins on Monday. This plant won a Platinum Peake Performance Award in 2015, and attendees will be able to see their operations and equipment, as well as talk with staff.

Upcoming Opportunities for Consultation and Comment

There are numerous opportunities that have been coming up lately for Tribes to provide comments to various federal agencies, as well as participate in consultation. Following is a list of some that may be of interest:

Public Comment Opportunity: EPA and Department of Army Propose First of Two Rulemakings to Define Scope of "Waters of the U.S." that Are Protected under the Clean Water Act

EPA and the Department of Army are proposing a rule that is the first of two rulemakings to define the scope of "waters of the United States" that are protected under the Clean Water Act. This proposed step 1 rule would rescind the Clean Water Rule and re-codify the regulatory text that existed prior to 2015 defining "waters of the United States" or WOTUS. Tribal Consultation Opportunity: New Authority under EPA's Clean Water Indian Set Aside Program

Recognizing that EPA has a technical assistance funding source specifically for tribal <u>drinking</u> water systems, but there is not a technical assistance funding source for tribal <u>wastewater</u> systems, on May 5, 2017 the FY17 Appropriations Act included a new authority that allows the Administrator to use up to \$2 million of Clean Water Indian Set Aside funds (which was funded at \$30 million) for training, technical assistance, and education related to the operation and maintenance of tribal wastewater utilities. EPA is currently evaluating the ways to distribute the funds. EPA anticipates that the tribal consultation and coordination period will extend until **July 28, 2017**. EPA has scheduled two national information and consultation calls with tribes, as noted below. The calls are scheduled as follows:

EPA Tribal Consultation: EPA's Guidance on Preparing for Waste and Debris Management for Major Disasters

EPA's Office of Land and Emergency Management/ (OLEM) will consult with tribes from June 29, 2017 -July 28,2017 on three draft documents for Preparing for Waste and Debris Management for Major Disasters: 1) Planning for Natural Disaster Debris guidance (PNDD), 2) Pre-incident All-hazards Waste Management Plan Guidelines: Four-step Waste Management Planning Process (4-steps document), and 3) All-hazards Waste Management Decision Diagram (diagram).
