#### Unique Visit to Little Traverse Bay Band of Odawa Indians

We were very excited to offer our second training and site visit of 2019, for the Tribal Superfund Working Group (TSFWG), this October. For this visit we worked closely with Traven Michaels, Environmental Response Specialist for the Little Traverse Bay Band of Odawa Indians (LTBB), who has been a very active member of the TSFWG. Traven invited Eric Hemenway, Repatriation and Archives Director of LTBB) to start the course off with a powerful history of the Tribe and their relationship to the lands and waters of northern Michigan.

We visited four sites: the Charlevoix Municipal Well Superfund Site, the Big Rock Nuclear Site, the Petoskey Manufacturing Company Superfund Site, and the Bay Harbor Cement Kiln Site. At each site we toured the area and heard presentations by site staff. There were lots of questions and discussions during each visit, as well as opportunities for attendees to share stories about their own sites. On our last day together we had a special presentation on the Topock Compressor Station Site by Dr. Charlie Schlinger, and concluded with our regular Talking Circle.

It was exciting to offer our first non-mining site training and visit for the TSFWG, and we are very appreciative of our friends at LTBB who made this unique opportunity possible!



# ITEP's Tribal Solid Waste Codes and Ordinance Project Starts Its Third Year

Arizona, October 15-17, 2019. Each tribal professional that attended was provided legal and technical support, email/web based meeting communication and one-on-one assistance in developing and implementing their codes and ordinances.

One attendee said "The most important thing I learned today is that the issues I am seeking to address in the community I work for are similar throughout the communities present in the training session. I will explain that "nothing is new under the sun." That we can learn from everyone's experience."

## Onsite Mentor Match Project: Saint Regis Mohawk Tribe at Chickasaw Nation

Lisa Furnace, Solid Waste Program Manager for the Saint Regis Mohawk Tribe, applied for ITEP's onsite mentor match to learn the best practices that could be applied to her community. Her Tribe is interested in possibly opening a community Thrift Store, to reuse various items instead of having them enter the waste stream, as well as providing Tribal members with quality products at reasonable prices. ITEP paired her with the Chickasaw Nation, whose ReUse Center won the 2018 Visionary Leadership Award. In 2018 alone this center diverted over 211,000 pounds of materials from the landfill, and served over 16,000 people. Lisa was able to visit the ReUse Center and see it in action, as well as spend time with staff from Chickasaw Nation learning how the Center was developed and how it is efficiently managed. After her visit, Lisa stated "I spent time with the director, Phillip Cravatt and we discussed what the Saint Regis Mohawk Tribe is doing in their solid waste program. I hope to share more information including our solid Waste Code which is in the process of begin revised. He was very interested in how our transfer station works since they don't currently have one. They have programs to benefit their people in addition to the reuse center."

One of the most powerful aspects of these onsite mentor visits is how often both the mentor and the mentee benefit, sharing ideas and brainstorming possible strategies that end up benefitting both Tribes. We are very thankful to our colleagues at both the Chickasaw Nation and the Saint Regis Mohawk Tribe for making this such a successful site visit.

The FY 2020 Farm to School Grant Program Request for Applications (RFA) is now available here. The solicitation will remain open until 11:59pm ET on December 13, 2019. FNS seeks to award up to \$10 million this fiscal year.

Schools and school districts, Indian tribal organizations, State agencies, local agencies, non-profits, and small- and medium-sized agricultural producers are encouraged to apply. The Implementation and Planning tracks return from previous years, and FY 2020 also marks the first time that a separate track is available specifically for State agencies (please see the RFA for additional eligibility requirements)
