### **TWAR Steering Committee in Washington DC for their Annual Meeting**

The Tribal Waste and Response Steering Committee (TWAR SC) was in Washington DC the week of February 17 for their annual meeting, where they met with senior US EPA Office of Land and Emergency Management (OLEM) staff, including Peter Wright, OLEM Assistant Administrator, Barry Breen, Principal Deputy Assistant Administrator, and Steven Cook, Deputy Assistant Administrator, as well as the directors of all the OLEM media-specific offices. In addition to meeting with their US EPA colleagues they also began work on their 2020 Priority Document, which is provided to senior US EPA managers as well as the National Tribal Caucus and the chairs of other Tribal Partnership Groups (TPGs). The annual Priority Document is one of the largest undertakings of the TWAR SC, and reflects priorities and issues that they see out in the field, as well as those they hear about from their colleagues at other Tribal Nations across the country. This document is also taken very seriously by senior US EPA management, and has led the Agency to undertake specific tasks and changes to address the priorities.

We greatly appreciate the phenomenal members of the TWAR SC, who dedicate so much of their time and passion – in addition to all the critical work they do for their own Tribes. **Webinar: Superfund and Brownfields Funding Vehicles for Tribes -** Mar 23, 2020, 1:00 - 2:30 PM EDT. The webinar will provide information about potential tribal funding vehicles to help address contaminated land as well as to build capacity within tribes for environmental response including:

- 1. Brownfields Funding Opportunities
- 2. Superfund Subpart O Funding Opportunities
- 3. Superfund Community Involvement Funding Opportunities

Among the topics covered will be what makes tribes eligible for each of the kinds of funding vehicles, what kinds of activities can be fund by each, and how Superfund and Brownfields funding interact (or don't). The webinar should provide tribal environmental professionals with a greater understanding of different potential funding vehicles that may support their work at impacted sites and should assist them in discussing funding options with their EPA regional counterparts. #### EPA Proposes Additional Amendments to the Regulations for Coal Combustion Residuals

- On Feb. 20, 2020, EPA announced further proposed revisions and flexibilities to the regulations for the management of coal combustion residuals (CCR), commonly known as coal ash, from electric utilities. EPA is proposing a number of revisions and flexibilities to the CCR regulations, the last in a set of four planned actions to implement the WIIN Act, respond to petitions, address litigation and apply lessons learned to ensure smoother implementation of the regulations. Specifically, EPA is proposing the following revisions:
  - 1. Procedures to allow facilities to request approval to use an alternate liner for CCR surface impoundments;
  - 2. Two co-proposed options to allow the use of CCR during unit closure;
  - 3. An additional closure option for CCR units being closed by removal of CCR; and
  - 4. Requirements for annual closure progress reports.

EPA is seeking comment on this proposal during a 45-day public comment period, during which a public hearing will be held. For more information, see: <a href="https://www.epa.gov/coalash">https://www.epa.gov/coalash</a>.
