I have enjoyed my brief two (2) years of service with the National Tribal Water Council (NTWC), of which I never attended a face-to-face meeting during my 'covid' tenure. My most memorial experiences are being able to make presentations and contribute to NTWC comments on Climate Change, Waters of the U.S. (WOTUS) and other water issues affecting Tribes and Alaskan Native Villages.

I have worked with the Pyramid Lake Paiute Tribe off/on for 23 years beginning in 1979, 12 years in the Environmental Department and 11 years in Fisheries, four (4) years of that as the Executive Director of Pyramid Lake Fisheries.



Major work accomplishments for the Pyramid Lake Paiute Tribe include the following:

- Developed the physical & bioassessment program (1989);
- Developed the lower Truckee River water quality monitoring program (1998);
- Approval of the Tribe's Water Quality Standards (WQS) by EPA in December 2008;
 and
- Awards received from EPA Region 9: Conner Byestewa Environmental Award (2008), Leadership Award (2009), and an EPA Region 9 Environmental Award in recognition of hard work, dedication and compassion to the well-being of people and the environment in their communities (2009).



To younger Tribal environmental professionals I would say, learn the cultural importance, i.e., traditional ecological knowledge (TEK) of your land, waters and wildlife from your elders while you can. Allow the wildlife and the land to speak to you, the streams and wetlands to teach you. We are losing that ability with today's technology and way of life dulling our natural senses that we used to depend on for survival.

EPA Releases Tribal Assessment Modules for Water Quality Assessments and Decisions

EPA's Office of Wetlands, Oceans and Watersheds is releasing assessment modules to assist EPA and tribes to learn and present information on water quality assessments and decisions. It was designed to be easily understood and modular for individual reuse needs. Each of these modules contain discussion points and activities to reinforce concepts in an innovative way. These modules will contribute to the advancement and resilience of tribal water quality programs.

The package contains four modules which focus on the four topics listed below:

- Understanding Water Quality Standards
- Overarching Considerations in Assessing Water Quality
- Assessing Data for Specific Water Quality Parameters
- Analyzing Data to Determine Use Support for Water Quality Assessment Reports

Potential Revisions to the Drinking Water Infrastructure Grant Tribal Set-Aside Allocation Formula Deadline: May 2, 2022

The EPA is initiating consultation and coordination with federally recognized Indian tribes to inform potential revisions to the Drinking Water Infrastructure Grant Tribal Set-Aside (DWIG-TSA) allocation formula. The allocation formula is used to determine how DWIG-TSA funds are distributed among the EPA Regions with federally recognized Indian tribes (currently all 10 EPA Regions). These funds are then distributed by EPA Regions to eligible tribal drinking water infrastructure projects within each Region. The deadline to submit comments is May 2, 2022. Implementation of EPA ORD Research - Safe & Sustainable Water Resources (SSWR) National Research Program

Deadline: May 31, 2022

EPA's Office of Research and Development is conducting a consultation and coordination process with federally recognized tribes on its Safe and Sustainable Water Resources (SSWR) National Research Program, one of ORD's six National Research Programs.

ORD provides the data, tools, and information that form the scientific foundation for EPA's work to protect the environment and safeguard public health. The Scoping Document is provided as background to give an overview of the draft planned research areas that will comprise the SSWR Strategic Research Action Plan (StRAP) for fiscal years 2023-2026. This provides our current view of what will be in the forthcoming SSWR StRAP and may be updated based on input through this consultation and additional input from EPA partner offices and regions. The StRAP serves as a planning guide for ORD's Research Centers as they design research products that address the needs of EPA program and regional offices, states, tribes, and external stakeholders.

EPA's Consumer Confidence Report (CCR) Rule Revision

Deadline: June 14, 2022

EPA is initiating consultation and coordination with federally recognized Indian tribes to obtain input on the agency's forthcoming proposed Consumer Confidence Report (CCR) Rule Revision. CCRs, also known as annual drinking water quality reports, provide consumers of community water systems information about their local drinking water quality. EPA is developing a proposal to revise CCR regulations to:

- Improve readability and accuracy of CCRs;
- Require biannual delivery of CCRs for large systems; and
- Allow electronic delivery of CCRs to consumers.

Community water systems are required by the 1996 SDWA amendment "Right to Know" rules to provide consumers with a summary of their water quality related information through a CCR. CCRs help to raise consumer awareness of where their water comes from, inform consumers of the process by which their water is delivered, and educate consumers on the importance of water safety measures (e.g., source water protection). Ideally, CCRs should start a dialogue between consumers and their community water system and increase consumer participation in decisions impacting their drinking water. CCRs allow consumers, to make more informed decisions regarding their drinking water. EPA is requesting your input on considerations to inform the development of the forthcoming proposed revisions to the CCR rule and requirements. The deadline to submit comments is June 14, 2022. Deadline: August 2, 2022

EPA is initiating consultation and coordination with federally recognized Tribes to receive input on proposed changes to the national allocation of Indian Environmental General Assistance Program (GAP) funds to tribal and intertribal consortia recipients. The proposed changes to the funding allocation formula, if adopted, will take effect for all GAP awards made with FY 2023 funds.

EPA is initiating consultation and coordination with federally recognized tribes to receive input on the draft 2022 Guidance on the Award and Management of Indian Environmental General Assistance Program Assistance Agreements for Tribes and Intertribal Consortia (2022 GAP Guidance). When final, the 2022 GAP Guidance will replace the 2013 Guidance and will be effective for negotiating and awarding GAP financial assistance agreements.

Potential EPA Actions to Increase Tribal Capacity to Maintain and Expand Nonpoint Source Management Deadline: September 30, 2022

EPA) is initiating consultation and coordination with federally recognized Indian tribes to inform potential EPA actions the Clean Water Act section (§) 319 national Nonpoint Source (NPS) program could take to better support §319-eligible tribes in their efforts to manage NPS pollution.

Section 319 of the Clean Water Act (CWA) authorizes EPA to provide financial assistance to states, territories, and eligible tribes and intertribal consortia to implement EPA-approved nonpoint source (NPS) management programs to prevent or reduce the water quality impacts of NPS pollution. Tribes have communicated to EPA the challenges

Grant Opportunities

The Fiscal Year 2022 Exchange Network Solicitation Notice

Deadline: May 1, 2022

The Fiscal Year (FY) 2022 Exchange Network (EN) Grant Program Solicitation Notice (SN) has been published to Grants.gov. Additional guidance tools, including optional fillable templates for the cover letter, project narrative (work plan), and budget narrative attachment form, are available for applicants on the EN website. Applicant webinars will be held in March and April; information on these sessions is available on the EN website.

FY 2022 will be the 21st year EPA will award competitive funding to eligible partners for projects through the Exchange Network Grant Program. Between FY 2002 and FY 2021, EPA provided approximately \$252 million for state, tribal, and territorial awards and associated program support through the grant program. As of October 1, 2021, all 50 states and the District of Columbia, 86 tribes, and 5 territories have received EN grants. These grants support better environmental decisions by promoting the use of more timely and consistent data which is shareable by partners across the EN as well as by environmental professionals and the public.

EPA Environmental Justice Small Grants Program

Deadline: May 20, 2022

EPA has announced a new Environmental Justice Small Grants (EJSG) Request for Applications (RFA) specifically for federally recognized Tribes, to fund tribal government efforts to establish or modify public participation programs where fair treatment and meaningful participation priorities have been impacted by the COVID-19 pandemic.

EPA anticipates to award 16 to 20 grants nationwide in amounts of up to \$100,000 per award. To be eligible for ARP funding, public participation programs must specifically address activities authorized by section 103(b) of the Clean Air Act (CAA; 42 U.S.C. 7403(b)) and/or section 1442 of the Safe Drinking Water Act (SDWA; 42 U.S.C. 300j-1).
