The National Tribal Water Council is currently accepting applications from tribal water professionals to fill two open membership positions. 1) Region 6 Representative

Update: Navigable Waters Protection Rule - Waters of the U.S. Step 2

On January 23, 2020, the U.S. EPA and the Department of the Army finalized the Navigable Waters Protection Rule to define "Waters of the U.S." The agencies have streamlined the definition so that it includes four simple categories of jurisdictional waters, provides clear exclusions for many water features that traditionally have not been regulated, and defines terms in the regulatory text that have never been defined before. The final rule also details 12 categories of exclusions, features that are not "Waters of the U.S."

Under the final "Step 2" rule, four clear categories of waters are federally regulated:

- Territorial seas and traditional navigable waters,
- Perennial and intermittent tributaries to those waters,
- Certain lakes, ponds, and impoundments, and
- Wetlands adjacent to jurisdictional waters.

This final rule will become effective 60 days after publication in the *Federal Register* and will replace the Step One Rule published in October 2019. Public Comment Opportunity: Update to the Regulations Implementing the Procedural ENDS: March 10, 2020 Provisions of the National Environmental Policy Act

The Council on Environmental Quality (CEQ) is proposing to update its regulations for implementing the procedural provisions of the National Environmental Policy Act (NEPA). This proposed rule would modernize and clarify the regulations to facilitate more efficient, effective, and timely NEPA reviews by federal agencies in connection with proposals for agency action. The proposed amendments would advance the original goals of the CEQ regulations to reduce paperwork and delays, and promote better decisions consistent with the national environmental policy set forth in section 101 of NEPA. If finalized, the proposed rule would comprehensively update and substantially revise the 1978 regulations.

Public Comment Opportunity: Proposed Information Collection Request (ICR) for 2020 Drinking Water Infrastructure Needs Survey and Assessment (DWINSA)

The EPA has issued a proposed ICR for the upcoming 2020 DWINSA, providing an opportunity for the public to provide input on the 2020 DWINSA. From September 6, 2019 to November 28, 2019, the EPA consulted with tribes on the forthcoming 2020 DWINSA, seeking input on the proposed policies and methods for the 2020 DWINSA. The Agency is currently reviewing and considering the comments that it received from tribes during the consultation period.

The proposed ICR provides another opportunity for commenting on the upcoming 2020 DWINSA. The EPA is particularly interested in receiving input from tribes on the estimates of the time burden on sampled water systems to respond to the survey questionnaire as well as the importance of including American Indian (AI)/Alaska Native Villages (ANV) systems in the 2020 DWINSA effort.

Tribal Consultation Opportunity: Draft Guiding Principles for Consulting with Alaska Native Claims Settlement Act (ANCSA) Corporations

In 2004, through two Consolidated Appropriations Acts, Congress directed all federal agencies to hereafter consult with corporations established under ANCSA in 1971 "on the same basis as Indian tribes under Executive Order 13175." The EPA has a long history of engaging with ANCSA corporations and now seeks to formalize this process. The proposed action is also responsive to the findings and recommendations of the Government Accountability Office's draft report, "Tribal Consultation Additional Federal Action Needed for Infrastructure Projects (GAO-19-22)," which recommended that the EPA "develop a documented policy or clarify existing policy to implement the statutory requirement to consult with [ANCSA corporations] on the same basis as Indian tribes under Executive Order 13175."

Public Comment Opportunity: 2020 National Pollutant Discharge Elimination System Multi-Sector General Permit

Ends: 60 Days After F.R. Publication

The U.S. Environmental Protection Agency (EPA) will be seeking public comment on the proposed 2020 National Pollutant Discharge Elimination System (NPDES) Multi-Sector General Permit (MSGP) for stormwater discharges associated with industrial activity in areas where the EPA is the NPDES permitting authority. Key proposed changes in the permit include new requirements for permit eligibility, authorization, monitoring, and updates to the stormwater control fact sheets.

The EPA will take comments on the proposal during a 60-day comment period, which will begin upon publication in the *Federal Register*. Comments can be submitted on www.regulations.gov for docket ID # EPA-HQ-OW-2019-0372.

Public Comment Opportunity: Preliminary Regulatory Determinations for EPA's Contaminant Candidate List (CCL) 4

Ends: 60 Days After F.R.
Publication

On February 20, 2020, the EPA announced and requested public comment on the preliminary regulatory determinations for eight contaminants on the fourth Contaminant Candidate List (CCL 4). The EPA is making preliminary determinations to regulate perfluorooctanesulfonic acid (PFOS) and perfluorooctanoic acid (PFOA) in drinking water and to not regulate six contaminants (i.e., 1,1-dichloroethane, acetochlor, methyl bromide (bromomethane), metolachlor, nitrobenzene, and RDX).

The EPA is taking public comment on these preliminary determinations for 60 days after publication in the Federal Register. Instructions for submitting comments are included in the announcement in the Federal Register via https://www.regulations.gov Docket ID No. EPA-HQ-OW-2019-0583. The docket will be open once the notice is published in the Federal Register.

The Tribal Resilience Program has announced grant opportunities to support Tribal Nations that need adaptation planning support and decision-making

information to prepare for extreme events and harmful environmental trends that impact tribal treaty and trust resources, economies, infrastructure, and human health welfare.

Funding Opportunity: Reduction in Lead Exposure via Drinking Water Grants

Application Deadline: April 20, 2020

Authorized under the Water Infrastructure Improvements for the Nation (WIIN) Act, the Reduction in Lead Exposure via Drinking Water Grant creates a new program under section 1459B of the Safe Drinking Water Act. The EPA is seeking applications to fulfill eligible projects/activities under the WIIN grant for two National Priority Areas. The EPA expects to award four to fifteen assistance agreement awards under two National Priority Areas.

- One to three awards are anticipated under the Reduction of Lead Exposure in the Nation's Drinking Water Systems through Infrastructure and Treatment Improvements National Priority Area, with an estimated total of \$17,100,000.
- Three to twelve awards are anticipated under the Reduction of Children's Exposure to Lead in Drinking Water in Schools and Child Care Facilities National Priority Area, with an estimated total of up to \$22,800,000.

The application period will remain open for submissions until April 20, 2020. Water systems located in an area governed by an Indian tribe are eligible to apply.
