


# **Highlight of NTWC Mid-Year Activities**



As we approach mid-year, the National Tribal Water Council (NTWC) offers a highlight of its current activities. Under the new administration, the NTWC has developed comment letters in response to proposed and revised policies and regulations.

Below is a summary of NTWC's completed activities:

## 2020/2021 Transition Brief

The NTWC submitted this brief to Radhika Fox, EPA Office of Water Assistant Administrator, and the brief listed 11 priority actions that the NTWC recommends action or addressed by the EPA because of a weakened protection of tribal waters and other resources on tribal lands.

### NTWC's 2020-2021 National Water Priorities

The NTWC submitted a letter to Jane Nishida, EPA Acting Administrator, identifying five (5) key priority actions that are most critical to the protection of tribal waters and tribal nations. This includes re-evaluating the Navigable Waters Protection Rule and the Clean Water Act Section 401 Certification rules, and the importance of completing and advancing the tribal baseline water quality standards rule.

## NTWC/EPA Spring 2021 Virtual Meeting

Each year the NTWC and EPA Office of Water staff meet twice a year to discuss, promote, and advance water issues of importance to tribes and the EPA. During this virtual meeting, the NTWC had an opportunity to dialogue with Radhika Fox, then Principal Deputy Assistant Administrator of the Office of Water, Benita Best-Wong, Deputy Assistant Administrator of the Office of Water, and Joann Chase, Director of the American Indian Environmental Office.

# EPA's Implementation of Executive Order 13175 Consultation and Coordination with Indian Tribal Governments

On March 31<sup>st</sup>, the NTWC submitted a comment letter on the EPA's implementation of consultation and coordination with tribal governments as part of President Biden's January 26<sup>th</sup> Tribal Consultation memorandum for all federal agencies.

Over the last several weeks, the NTWC was reviewing and providing recommendations on EPA Office of Water's Draft Tribal Action Plan (TAP). The TAP outlines and prioritizes four areas EPA will focus on over the next four years in order to strengthen the Nation-to-Nation Relationship to Secure a Sustainable Water Future for Indian Country.

In July, the NTWC will be working on comment letters on proposed and revised EPA policies and regulations, including the Clean Water Act Section 401 Rule, establishing baseline tribal water quality standards, and Clean Water Act Water Quality Standards Regulations revisions.

Additional activities include updating the NTWC Program Priorities document for FY 2021-2022, participating in the Tribal PFAS Work Group, and continuing to develop a Tribal Water Quality Standards guidebook.

# Tribal Consultation Opportunity: Potential Promulgation of Tribal Baseline Water Quality Standards under the Clean Water Act

Ends: September 13, 2021

The U.S. Environmental Protection Agency (EPA) is initiating consultation and coordination with federally recognized Indian Tribes on an upcoming rulemaking that would establish tribal baseline water quality standards (WQS) under the Clean Water Act for waters on Indian reservations that currently do not have EPA-approved WQS in place.

Water quality standards define the goals for water bodies and establish the criteria that must be met to support those goals, serving as the foundation for controlling pollution as mandated by the CWA. With the proposed rulemaking, the EPA will be better equipped to work with tribal governments to improve water quality in impaired waters and prevent future degradation of tribal waters.

The consultation ends on September 13, 2021. The EPA is holding a listening session for tribes on Thursday, July 8, 2021 (1:00 to 3:00 PM EDT). # Tribal Consultation Opportunity: Potential Revisions to the Clean Water Act Water Quality Standards Regulations Ends: September 13, 2021

The U.S. Environmental Protection Agency (EPA) is initiating consultation and coordination with federally recognized Indian Tribes to inform of potential revisions to the federal Clean Water Act (CWA) water quality standards (WQS) regulations. Many tribes, through treaties and equivalent agreements with the U.S. government, hold reserved rights to aquatic or aquatic-dependent resources in waters outside the boundaries of federal Indian reservations, or in areas otherwise subject to state and federal jurisdiction. EPA's Office of Water is considering pursuing a change to the federal WQS regulations at 40 CFR Part 131 to explicitly and sustainably protect tribal reserved rights in state waters, consistent with existing legal obligations. This action is separate from and complementary to the EPA's action to establish baseline WQS under the CWA for waters on Indian reservations that do not have EPA-approved WQS currently in place.

# **EPA Multipurpose Grants to States and Tribes to Address Environmental Changes**

Deadline: July 9, 2021

The U.S. Environmental Protection Agency (EPA) is announcing the availability of Multipurpose Grant (MPG) funding to support states, Tribes and territories in addressing high-priority environmental issues, including PFAS, environmental justice and climate change.

A total of \$1,500,000 will be available to tribes delegated federal regulatory authority through the treatment in a similar manner to a state (TAS) process, and tribes approved to operate certain environmental regulatory programs through non-TAS approval provisions found in federal environmental statutes and regulations. MPG funds are to be used to implementation activities performed by a tribe pursuant to the authority delegated or approved for the tribe.
