

NTWC's Comment Letter on EPA's Proposed Revisions to the Federal Water Quality Standards Regulations to Protect Tribal Treaty Rights

On November 28, 2022, the EPA Administrator signed a proposed rule to revise the water quality standards (WQS) regulation at 40 CFR part 131 to clarify and prescribe how state and federal WQS must protect aquatic and aquatic-dependent resources reserved to tribes through treaties, statutes, executive orders, or other sources of federal law, in waters where those rights exist. The proposed revisions would create a regulatory framework that would be applied case-specifically to help ensure protection of resources reserved to tribes, such as fish and wild rice.

Overall, the NTWC is supportive of the proposed rule. The NTWC did take the initiative to craft and submit a 12-page comment letter that included recommendations on specific provisions of the proposed rule. A sample of the recommendations made by the NTWC are listed below:

- Under the State Review and Revision of WQS section The NTWC recommends that
 the EPA adopt a process that requires states to contact all tribes with treaty protected
 rights within their borders, meet with them separately from the general public, and
 take their input into account when reviewing WQS.
- The Council recommends the EPA include a dispute resolution procedure within its tribal consultation process when right holders disagree on EPA's conclusions of whether state WQS are protective of the tribal reserved rights.
- Under the Minimum Requirements for WQS Submission section The NTWC recommends the provision recognize Traditional Ecological Knowledge (TEK) as one method for developing standards protecting tribal reserved rights uses.

Tribal and State Webinar Series on the Revised Definition of "Waters of the United States" (2023 Rule)

On January 18, 2023, the EPA and the Department of the Army (Army) published the final "Revised Definition of 'Waters of the United State" rule in the Federal Register. The rule became effective on March 20, 2023. The agencies developed this rule with consideration of the relevant provisions of the Clean Water Act and the statute as a whole, relevant Supreme Court case law, and the agencies' technical expertise after more than 45 years of implementing the longstanding pre-2015 "waters of the United States" framework. This rule also considers the best available science and extensive public comment to establish a definition of "waters of the United States" that supports public health, environmental protection, agricultural activity, and economic growth.

EPA and Army are hosting a series of webinars in March and April specifically for Tribes and States to learn about the final rule and implementation considerations. Request for Nominations for the National Drinking Water Advisory Committee

EPA is now accepting nominations of qualified candidates to be considered for three-year appointments to the National Drinking Water Advisory Council (NDWAC or Council). The 15-member Council was established by the Safe Drinking Water Act (SDWA) to provide independent advice, consultation, and recommendations to the EPA Administrator on matters relating to activities, functions, policies, and regulations under the SDWA. EPA is soliciting nominations to fill anticipated vacancies in 2023 with three-year appointments from December 2023 through December 2026.


EPA is seeking nominees from the general public; appropriate state and local agencies concerned with water hygiene and public water supply; and representatives of private organizations or groups demonstrating an active interest in the field of water hygiene and public water supply, including nominees associated with small, rural public water systems.

EPA Releases the Final Clean Water Act Section 106 Tribal Guidance

On January 23, 2023, the EPA released the final 2023 Clean Water Act Section 106 Tribal Guidance. The Section 106 Tribal Guidance, which supersedes the 2007 Final Guidance on the Awards of Grants to Indian Tribes under Section 106 of the Clean Water Act, underwent significant engagement, input, and consultation with Tribal governments, Tribal partnership groups, and Tribal water quality professionals.

The guidance provides clear, comprehensive, updated, and succinct language that is relevant and applicable to Tribes. It also discusses how Indigenous Knowledge can be supported and leveraged using Section 106 funding. GRANT OPPORTUNITIES

EPA Environmental Justice Grants

Deadline: April 14, 2023

EPA announced \$100 million in Environmental Justice grant funding. This is the largest amount of environmental justice grant funding ever offered by EPA. This funding, made possible through President Biden's Inflation Reduction Act, marks the largest amount of environmental justice grant funding ever offered by the Agency. EPA has published two Requests for Applications for this funding through the Environmental Justice Collaborative Problem-Solving (EJCPS) Cooperative Agreement Program and the Environmental Justice Government-to-Government (EJG2G) Program.

The Environmental Justice Collaborative Problem-Solving Program (EJCPS) Cooperative Agreement Program

The EJCPS Program will provide an estimated \$30 million in funding directly to community-based nonprofit organizations (and partnerships of these organizations), with \$5 million reserved for small community-based nonprofit organizations with five or fewer full-time employees. In total, the Agency anticipates funding approximately 50 awards of \$500,000 and 30 awards of \$150,000.

EPA's EJCPS Cooperative Agreement Program provides financial assistance to eligible organizations working on or planning to work on projects to address local environmental and/or public health issues in their communities. The program assists recipients in building collaborative partnerships with other stakeholders (e.g., local businesses and industry, local government, medical service providers, academia, etc.) to develop solutions that will significantly address environmental and/or public health issues at the local level.

The Environmental Justice Government-to-Government (EJG2G) Program

The EJG2G Program (formerly known as the State Environmental Justice Cooperative Agreement program) will provide an estimated \$70 million in funding. Of this, \$20 million will be for State governments to be used in conjunction with Community-Based Organization (CBO) partners, \$20 million will be for local government with CBO partners, \$20 million will be for Federally Recognized Tribal Nations with CBO partners, and \$10 million will be for U.S. territories and remote tribes with limited access to CBO partners. In total the Agency anticipates funding approximately 70 projects of up to \$1 million each for a 3-year project.

The EJG2G Program works to support and/or create model state activities that lead to measurable environmental or public health results in communities disproportionately burdened by environmental harms and risks. These models should leverage or utilize existing resources or assets of state agencies to develop key tools and processes that integrate environmental justice considerations into state governments and government programs.

Under both EJCPS and EJG2G programs, EPA will be giving special consideration to the following focus areas:

- Projects addressing climate change, disaster resiliency, and/or emergency preparedness
- Projects located in and/or benefitting rural areas
- Projects conducting Health Impact Assessments (HIA)

Applicants interested must submit proposal packages on or before April 14, 2023, to be considered for the available funding. Applicants should plan for projects to begin on October 1, 2023.

EPA's Climate Pollution Reduction Grants

Deadline: June 15, 2023

EPA's Climate Pollution Reduction Grants program will provide noncompetitive planning grant opportunities for federally recognized Tribes, tribal consortia, and U.S. Territories interested in participating in the Climate Pollution Reduction Grants (CPRG) program will provide grants to states, territories, tribes, air pollution control agencies, and local governments to develop and implement plans for reducing greenhouse gas emissions and other harmful air pollution. Section 60114 of the Inflation Reduction Act provides an investment of \$5 billion to support these efforts to develop and implement strong, local greenhouse gas reduction strategies. This two-staged grant program provides funding of \$250 million for noncompetitive planning grants, and \$4.6 billion for competitive implementation grants.

The CPRG program will provide significant resources to state, territory, local, and tribal governments to develop ambitious climate action and air pollution reduction plans and to implement measures from those plans. TRIBAL CONSULTATION OPPORTUNITIES

EPA's Proposed Re-Issuance of EPA's General Permit for Ocean Disposal of Marine Mammal Carcasses under the MPRSA

Deadline: April 30, 2023

EPA has initiated consultation and coordination with federally recognized Indian tribes on EPA's proposal to reissue the existing General Permit for Ocean Disposal of Marine Mammal Carcasses, pursuant to the Marine Protection, Research, and Sanctuaries Act (MPRSA), also known as the Ocean Dumping Act. Under the MPRSA, general permits expire after seven years. EPA intends to review and reissue this permit as it is set to expire in 2024, after issuance in 2017. The general permit authorizes federal, state, tribal, and/or local governmental authorities, as well as any Alaska Native, who already may take marine mammals under the Marine Mammal Protection Act and Endangered Species Act, to dispose of all or part of a marine mammal carcasses at sea under MPRSA.

Your tribe may be interested in this general permit because disposal at sea may relate to traditional hunting or whaling practices; however, the permit was developed and intended to avoid interference with such practices. The permit is primarily intended to be used in public health threat situations, for example, after discovery of a carcass washed ashore in an advanced state of decay, and there is not another viable option for the carcass other than disposal at sea. Additionally, during the pre-proposal consultation period, EPA is soliciting input on the reporting requirements described in Section B of the General Permit for Ocean Disposal of Marine Mammal Carcasses. Section B authorizes any Alaska Native to transport and dispose of a marine mammal carcass in ocean waters but requires the permittee to submit a report on disposal activities annually.

EPA plans to hold two identical informational webinar and listening sessions to provide an overview of this forthcoming rulemaking and to receive input from tribal representatives about this action.

EPA's Effluent Limitations Guidelines and Standards for the Organic Chemicals, Plastics and Synthetic Fibers Point Source Category (OCPSF ELG)

Deadline: May 8, 2023

EPA has initiated consultation and coordination with federally recognized Indian tribes on forthcoming proposed revisions to the Organic Chemicals, Plastics and Synthetic Fibers (OCPSF) Effluent Limitations Guidelines and Pretreatment Standards (ELGs). This ELG revision is focused on facilities that manufacture per- and polyfluoroalkyl substances (PFAS). Revised limitations on the discharge of pollutants from OCPSF facilities, once finalized by rule, would subsequently be incorporated into National Pollutant Discharge Elimination System (NPDES) permits for direct dischargers, and permits or other control mechanisms for indirect dischargers, potentially reducing pollutant discharges into waters of the United States.

PFAS can be found in the environment and in humans across the world as they have been, and continue to be, released into the environment. On September 14, 2021, EPA announced its decision to undertake a rulemaking to determine whether more stringent limitations and pretreatment standards for PFAS manufacturing facilities are appropriate and consistent with the technology-forcing statutory scheme and goals of the Clean Water Act.
