

2020 A Year in Review: National Tribal Water Council Highlights

Below are a few highlights of the Council's accomplishments in 2020.

- The Council recruited and welcomed two new members this past year.
 Daniel Mosley, Pyramid Lake Paiute Tribe, was selected to serve as the At-Large Member, and Stephen Wolfe, Seneca-Cayuga Nation, was selected to serve as the Region 6 Representative.
- The Council partnered with the National Tribal Toxics Council, Tribal Science Council, and Tribal Waste and Response Steering Committee to form a Tribal PFAS Work Group. The objectives of the work group are to evaluate the successes in addressing PFAS across tribal nations, advocate for tribal nations, develop communication methods about PFAS, and develop guidance documents.
- The Council crafted and submitted three comment letters on proposed rules, regulations or policies, including: (1) Council on Environmental Quality's proposed Update to the Regulations Implementing the Procedural Provisions of the National Environmental Policy Act; (2) EPA's Draft Guiding Principles for Consulting with Alaska Native Claims Settlement Act Corporations; (3); and the US Army Corp of Engineers' Proposal to Reissue and Modify Nationwide Permits. Additionally, the NTWC completed and distributed an analysis document on the Navigable Waters Protection Rule and a memorandum on the Clean Water Act Section 401 Certification Final Rule. Council members participated and presented in tribal meetings and conferences, including: (1)
Region 6 Regional Tribal Operations Committee (RTOC); (2) Tribal Lands and Environment Forum –
Virtual; and (3) National Tribal and Indigenous Climate Conference - Virtual. Also, the Council was
featured in the EPA's 50th Anniversary for Celebrating Partnerships. Additionally, the Council jointly
held a virtual fall meeting with the EPA Office of Water.

Updates and Announcements

EPA's Vessel Incidental Discharge Act Proposed Rule

EPA's Notice of Proposed Rulemaking - Vessel Incidental Discharge National Standards of Performance – published in the Federal Register for public comment on October 26th (docket ID EPA-HQ-OW-2019-0482). Comments on the proposed rule must be received by November 25, 2020. The proposed rule would establish national standards of performance for incidental discharges from primarily commercial vessels under VIDA. The proposed rule details specific discharge standards that would apply to 20 different types of vessel equipment and systems, as well as general discharge standards that would apply more broadly to all types of vessel incidental discharges.

Tribal Consultation and Public Comment Opportunities

Tribal Consultation Opportunity: Proposed Rulemaking for Market-Based Approaches under the National Pollutant Discharge Elimination System Program

Ends: January 7, 2021

The EPA is proposing a rulemaking to address Market-Based Approaches under the National Pollutant Discharge Elimination System (NPDES) Program. The proposed regulation will provide clarity to NPDES permitting authorities, regulated entities, and stakeholders interested in participating in market-based compliance approaches, including water quality trading. The action may be of interest to tribes interested in participating in water quality trading to meet permit effluent limitations for tribally owned facilities or to generate pollutant reduction credits from tribally owned point source or nonpoint source facilities. The action may interest tribal governments that provide certification under Section 401 of the Clean Water Act for permits that include conditions allowing for the use of market -based approaches.

The consultation period will end on January 7, 2021. The EPA will be holding an informational webinar on Tuesday, December 8, 2020, from 2:00 PM to 4:00 PM (EST). To register, please visit: https://attendee.gotowebinar.com/register/5921972236716908556

Northwest and Southwest Climate Adaptation Science Centers Tribal Climate Adaptation Research Projects

Deadline: December 17, 2020

The Northwest and Southwest Climate Adaptation Science Centers invite federally recognized tribes and tribal organizations to submit a Statement of Interest for tribal climate adaptation research projects for fiscal year 2021. Projects will focus on the Center's priorities, which include: (1) management of aquatic species; (2) management of at-risk species and habitats; (3) management of invasive species and diseases; (4) management of forest ecosystems; and (5) human dimensions of climate adaptation.

Statement of interest submitted to the Northwest Climate Adaptation Science Center should have geographic footprints within Idaho, Oregon, Washington, or Northern California. Statement of interest for the Southwest Climate Adaptation Science Center should have geographic footprints within Central/Southern California, Nevada, Utah, Arizona, or New Mexico. Interested applicants must submit a Statement of Interest by December 17, 2020 (5:00 PM EST).

FY2021 Tribal CWA 319 Competitive Grant Request for Applications

Deadline: January 14, 2021

The EPA's FY2021 Tribal Clean Water Act Section 319 Competitive Grant is targeted to support implementation of nonpoint source (NPS) best management practices to control sources of NPS pollution. Applicants may include other eligible activities that support implementation work, but an application should primarily focus on implementing best management practices that will directly protect or restore water quality.
