### Purpose

To promote economic and social self-sufficiency for American Indians, Alaska Natives, Native Hawaiians, and Native Pacific Islanders.

ANA is interested in supporting community driven projects designed to grow local economies, increase capacity of tribal governments, strengthen families, preserve Native cultures, and increase self-sufficiency and community well being.

#### There are 3 areas of Program Interest

- 1. Social Development
- 2. Economic Development
- 3. Governance





#### SOCIAL

- <u>Community Living</u> Developing and coordinating services to assist people with disabilities by helping them reach their maximum potential through increased independence, productivity, and integration within the community
- <u>Strengthening Families</u> Incorporating culturally relevant strategies to strengthen families and promote family preservation, responsible parenting, and healthy relationship skills; and to foster the well-being of children
- <u>Suicide Prevention</u> Promoting safety, resilience, and protective factors necessary to foster mental health and reduce incidences of suicide and suicidal ideation
- Youth Development Improving the well-being of youth through life-skills training, workforce development training, mentoring programs, substance abuse programs, and preventing pregnancies, suicides, and juvenile crime





#### **ECONOMIC**

- <u>Asset Building</u> Increasing availability of effective financial education and other asset-building strategies for individuals and families
- <u>Economic Stability</u> Conducting the necessary planning and/or research to support achievement of long-range economic development goals. Examples may include establishing a separate division to administer economic development programs or performing gap or value-added analyses to identify strengths and weaknesses in the local economy. Strengthening an organization's capacity to deliver programs that promote economic development and security
- <u>Infrastructure</u> Developing infrastructure (transportation systems, communication, distribution networks, financial institutions, technology, etc.) to support the local workforce and make business activity possible
- <u>Subsistence</u> Enhancing subsistence and agricultural activities to retain or revitalize traditional native food sources and practices



### **GOVERNANCE**

- <u>Emergency Preparedness</u> Planning and coordinating emergency response services within the community and with state and local governments to protect against the acts of nature and other catastrophic events such as floods and hazardous material exposure
- Governmental Administration Developing or amending tribal constitutions, by-laws and codes, and council or executive branch policies and procedures to improve the regulatory, judicial, and administrative infrastructure of tribal and village governments; support and enforce business and investment transactions, contracts, and property rights; rights and procedures addressing family and child welfare issues; and enhance intergovernmental relations, including clarifying tribal jurisdiction

### Purpose

To promote economic and social self-sufficiency for American Indians, Alaska Natives, Native Hawaiians, and Native Pacific Islanders within Alaska. (Alaskan Based Projects)

ANA is interested in supporting community driven projects designed to grow local economies, increase capacity of tribal governments, strengthen families, preserve Native cultures, and increase self-sufficiency and community well being.

#### There are 3 areas of Program Interest

- 1. Social Development
- 2. Economic Development
- 3. Governance





#### SOCIAL

- <u>Rescue archaeology</u> Recovery of cultural material due to climate change, such as exposure of cultural artifacts due to permafrost melting.
- <u>Community Health</u> Promoting improved access to health care and quality of care through coordinated Village and regional approaches, expanding access to healthy foods available in Native Villages, and supporting environmental health.
- <u>Arts and culture</u> Developing or enhancing activities at the Village level that promote, preserve, or restore Native Village culture and arts.





#### **ECONOMIC**

- Energy-related activities Projects that promote traditional energy activities and practices that support conservation and help to mitigate the high costs of the purchase, transportation, and storage of fuel in Alaskan Villages, especially strategic energy plans that have been identified in tribally approved strategic energy plans. Examples include projects to implement renewable energy resources at the village level such as bio-energy, geothermal, hydropower, solar, wind, or other methods appropriate to the geographical location.
- <u>Subsistence</u> Enhancing subsistence and agricultural activities to retain or revitalize traditional food sources and practices at the Village level.



### **GOVERNANCE**

- Governmental administration Improving Villagelevel capacity related to regulatory, judicial, and administrative infrastructure, including clarifying jurisdiction, developing or amending codes and procedures, enforcing contracts and property rights, and addressing family and child welfare issues.
- <u>Comprehensive strategies</u> Developing Village-level strategies to assess and address the needs of children, youth, and community members.



### **GOVERNANCE**

 Adaption and mitigation of impacts of climate change – Assessment, planning, and implementation of efforts to adapt to climate change and to effectively respond to its impacts at the Village level, including efforts to address the effects of climate change on local fisheries and fresh water supplies, effects that increase the risk of flooding and wildfires, assessment and planning for relocation, and mitigation of impacts of erosion and permafrost melt.

\*\*For Alaska-Specific SEDS projects, ANA will consider funding core administrative capacity building projects at the village government level if the village does not have governing system in place

#### **PURPOSE**

SEEDS initiative is to promote job growth and business development in Native communities that are experiencing challenging economic conditions.

#### **KEY PRIORITIES**

- 1) creation of sustainable employment opportunities
- 2) professional training and skill development that increases participants' employability and earning potential
- **3)** creation and development of small businesses and entrepreneurial activities
- **4)** a demonstrated strategy and commitment to keeping the jobs and revenues generated by project activities within the Native communities being served.



#### **Areas of Interest**

- <u>Commercial Trade</u> Strengthening local economies by increasing the availability of, or demand for, locally produced goods and services.
- Entrepreneurship and Microbusiness Promoting entrepreneurial development through business incubators and other activities that support businesses and market the availability of local products or services.
- <u>Professional Development</u> Providing professional training, skill development (including soft skills, basic skills, or technical skills), or certification that will enhance participants' employment and earning prospects.

#### **PURPOSE**

The Native American Language Preservation and Maintenance (P&M) program is to assist Native Americans in ensuring the survival and continuing vitality of Native American languages.





#### **Areas of Interest**

- The compilation, transcription, and analysis of oral testimony to record and preserve a Native American language.
- The development, printing, and dissemination of materials to be used for the teaching and enhancement of a Native American language.
- The establishment and support of a community Native American language project to bring older and younger Native Americans together to facilitate and encourage the transfer of Native American language skills from one generation to another.

#### **PURPOSE**

The Native American Language Preservation and Maintenance- Esther Martinez Immersion (EMI) program is to provide financial assistance to community-driven projects designed to preserve Native American languages through Native American language nests, Native American language survival schools, and Native language restoration programs.





### Requirements

Native American Language Nests are site based education programs that provide child care and instruction in Native American languages for at least 10 children under the age of 7 for an average of at least 500 hours per year per child, provide classes in such languages for parents or legal guardians of children enrolled in such language nests, and must be located in areas with sufficient numbers of Native American children to provide instruction and child care for at least 10 children under the age of 7.





### Requirements

Native American Language Survival Schools are schools for school-age children providing at least 500 hours of Native American language instruction to at least 15 students which develop instructional courses and materials, provide teacher training, and work towards achieving native American language fluency and academic proficiency in mathematics, reading, and sciences.





### Requirements

Native American Language Restoration Programs are education programs that provide instruction in at least one Native American language for the community served, provide teacher training programs for the teachers of Native American languages, develop instructional materials for such language restoration programs, and work toward the goal of increasing fluency and proficiency in at least one Native American language.

## Environmental Regulatory Enhancement

#### **PURPOSE**

The Environmental Regulatory Enhancement (ERE) program is to provide funding for the costs of planning, developing, and implementing programs designed to improve the capability of tribal governing bodies to regulate environmental quality pursuant to federal and tribal environmental laws.





## Environmental Regulatory Enhancement

#### **Areas of Interest**

- Providing training and education to employees responsible for enforcing, or monitoring compliance with, environmental quality laws
- Establishing baseline condition for regulatory purposes
- Building the technical and program capability of the tribe or organization to perform essential environmental program functions to meet tribal and federal regulatory requirements
- Establishing demonstration projects to exhibit technologies, which can lead to compliance with environmental regulations
